This is a binding agreement between us (the breeder) and you (the original buyer). By purchasing a puppy from us, you are agreeing to **THE TERMS** mentioned in this contract. Every effort is made to guarantee a puppy from us is in good health at the time of adoption or delivery so we ask that you have it checked by your vet w/ 5 days of getting it. Proof of this visit **MUST BE SENT TO US**. Visits to **Petsmart (Banfield Vet)** are not accepted! We can't control what your puppy encounters after leaving us, so if you **do not have your puppy examined, then our contract is VOID**. If the vet finds the puppy well and healthy at that visit, **our guarantee is complete**. If the Vet finds anything wrong with the puppy at that time, you must notify the breeder immediately. If it is a treatable condition, you can return the puppy to us and we will treat it at expense, returning it to you when healthy. If it is not treatable we will replace the puppy with an equal value puppy when one is available. **The defective puppy must be returned to us with written notice from the Vet** as to the defect or condition in order to get a replacement. All paperwork **MUST BE RETURNED** with the puppy and vaccinations must be up to date.

Your puppy has had vaccinations for Parvovirus, Distemper Adenovirus and Parainfluenza appropriate to its age. It has been dewormed and treated for all parasites. A written health record will be included along with its food, **Diamond Natural Small/Medium Breed Puppy**. Vaccinations are given @ 7 wks. of age & given at 3 week intervals to 16 wk. of age. Wormings are started at 2 wks. & given at 2 wk. intervals. It is very important to continue a vaccination schedule as recommended by your Veterinarian. **PLEASE DO NOT ALLOW THE PUPPY TO BE OUT OF A KENNEL IN RECEPTION AREA OF VET'S OFFICE. IT'S BEST TO CLEAN OFF THE EXAM TABLE BEFORE PLACING YOUR PUPPY ON IT**. Another thing....don't allow puppy to be given any vaccinations that are not w/ 3 days of when they are due. Your animal warranty is against developing a contagious disease w/ 5 days of purchase. We **DO NOT** cover anything that is **NOT** life threatening. Conditions such as but not limited to Worms, Earmites, Colds, Giardia Hypoglycemia or Coccidiosis can be dormant but they are treatable conditions and do not warrant a return. Undescended testicles, Over or Underbites, and Luxating Patellas are not life threatening so they are not covered. **Use extreme caution when socializing your puppy until fully vaccinated. Avoid dog parks and other public areas but it's ok to socialize your puppy with fully vaccinated dogs in safe places like your home.**

This contract is non-transferrable, if you choose not to keep the puppy. **NO CASH REFUNDS WILL BE MADE!** **If a replacement is offered and refused, then we have fulfilled our obligation.** Every effort is made to offer a replacement puppy equal to the one purchased but should you choose a different one that isn't comparable to the original one, you will have to pay the difference. For example, male vs female, tiny toy vs toy. If the puppy dies, an autopsy **MUST BE DONE** by a state lab explaining the cause of death and must be furnished to us before a replacement can be determined to be warranted. No replacement will be made if this procedure isn't done. Please remember that a replacement puppy is only given if all the terms are met and a life threatening condition was diagnosed by a licensed veterinarian, not for any other reason. Any expenses incurred after a puppy leaves our care, such as vet bills, autopsy, etc. is at the buyers' expense. Our contract is void in case of accidental injury which can happen. We make no guarantees on size, color, personality, temperament, fertility or show ability. All of our puppies are sold as pets only. If you decide to show or breed your puppy, then we, as the breeders, are not liable. Registration papers are furnished to you at adoption or mailed to you if they aren't available when the puppy leaves to go home with you.
